

The saddest declaration of November 08th 2016 is an unforgettable experience for more than 125 crores of Indians and is going to be one of the economic events of our time. The Prime Ministerial declaration on 8th November 2016 opened up new political, economic, social and legal discussion in the country. The discussions as usual follow the popular patterns of analyzing the merits and demerits of demonetization, efficiency of the measure in achieving the envisaged outcomes, its timing, its managerial issues, institutional frictions and inertias, legality and legitimacy of the policy decisions etc. interestingly, the notification is coupled with another major economic reform, i.e., a shift towards digital economy. The implications of such reforms attempting a sweeping change in economic structure are beyond human imaginations.

Never the less the uncertainty still looms on its possible impact on various sectors of economy and its elements. However, this remains a fact that during these days of demonetization, the fundamental rights have been suppressed and people suffered immensely. Persons of all ages, gender, ill or healthy, able or disabled were compelled to stand in the queue of Bank branches/ATMs, either to change their hard earned money, which those have saved in the form of small deposits/buffer money to met with the contingencies of their lives or to get some currency to fed the empty stomach of those loved once who depend on them. This in fact, they did by sacrificing their so called the small casual temporary engagement(s), a source of their survival, which unfortunately pushed them further to the state of misery and hunger.

It is on record that hundreds of person died while in queue at ATM/Bank Branches. Their deaths in civilized nation must have been condoned officially and financial support must have been made guaranteed to their families. However, the Indian democracy is waiting for this as yet with hope. The number of deaths recorded is in fact a fraction of the number of deaths actually met. Thousands of people have breathed their last for want of medicine and medical treatment that could not be provided by their dear ones to them for want of the new currency in their hand, the currency acceptable to the nursing homes and medical shops. On the same lines where is the count of those deaths when the wedding could not be solemnized and in some stances either bride or her parents committed suicide.

Whether shall be accounted for or not, is an important policy matter when such reforms, if are attempted. This raise on one hand, the questions of accountability and responsibility and on the other, the need for efficiency and enforceability of monetary laws gain prominence and compete equally well, if not higher. The balancing is more complex, when claims are presented in the wrapper of public and national interest. Therefore, the academic fraternity of Faculty of Law of Mohammad Ali Jauhar University, Rampur, feels that there is much more to be discussed about Human Rights in Reference to the Present National Economic Scenario: Issue and Challenges, new demonetization notification than from the popular standpoints. Moreover the experiences of the new notification have been unalike in different states of the country. It is closely related to their market structure, to the level of social and political maturity of the populations; and to the trading traditions and customs. We hence organize this national seminar to collate various perspectives from different parts of the country and to mark a research co-ordination ion the area of Law and Monetary Policy.
